O R D E R

IT IS ORDERED that Orchard Grass Sanitation, Inc., shall file an original and five copies of the following information with the Commission, with a copy to the Attorney General's Division of Consumer Intervention by October 28, 1981. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case will be dismissed.

1. Provide documentation in the form of copies of checks or invoices for the purchase of the land where the sewage treatment plant is located.
2. If the land in item 1 was purchased from Titan Group, Inc., or Titan Development Corporation or any other related company, provide documentation which shows the original price paid by the parent or related company.
3. Provide copies of all invoices or other documentation for the total purchase and installation cost of the 100,000 GPD and 300,000 GPD sewage treatment plants.

4. Provide invoices or other documentation for all other treatment plant and equipment included in the total value of utility plant in service.

5. Provide details of the interim financing arrangements for the previously mentioned facilities.

6. If any portion of the cost of the assets of Orchard Grass Sanitation, Inc. has been written off as an expense for tax purposes by either Orchard Grass Sanitation, Inc., or any affiliated corporations, please provide a schedule showing the amounts.

7. Has any portion of the cost of said assets been recovered in any manner from the property owners served by this system? If the answer is "yes", provide an analysis of the total amount recovered and the manner of payment. If the answer is "no", provide the price of the lots in the subdivision served by this utility, and the original cost of the land and improvements (separated) for tax purposes.

8. Were any payments made by the developer of the subdivision to Orchard Grass Sanitation, Inc., for construction of the sewer system?

9. Please provide copies of the consolidated federal income tax returns and copies of the consolidated Kentucky income tax returns for Orchard Grass Sanitation, Inc., and the affiliated companies for the years 1973 thru 1980.
