ORDER

IT IS ORDERED that Simpson County Water District, shall file an original and five copies of the following information with the Commission, with a copy to the Attorney General's Consumer Protection Division by September 4, 1981. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case will be dismissed.

- (1) Provide a comparative income statement according to the Uniform System of Accounts, showing test period per books, revenues and expenses, pro forma adjustments to those figures and the adjusted revenues and expenses.
- (2) Provide an analysis of the other income for the district for the test year and the five preceding calendar years.
- (3) Provide documentation for the use of a 1.2 debt service coverage for the existing and the proposed bond issue.

- (4) Provide a reconciliation of the difference in the number of existing customers between the FmHA Letter of Conditions and those used in the pro forma adjustments in the engineers report.
- (5) Provide an analysis of sales to each class of customer for the test year and for the five preceding calendar years.
- (6) Provide the total amount of water purchased during the test year and the five preceding calendar years.
- (7) Provide a detailed explanation and analysis for the increase in operation and maintenance cost as shown in table IV-5a of the engineers report contained in Exhibit A.
- (8) Provide a detailed explanation of the following expense adjustments:
 - (1) Adjustment 1 Explain in detail the derivation of the 13% line loss.
 - (2) Adjustment 19 Provide an explanation of the 202,762 figure contained in the adjustment.
 - (3) Adjustment 18 Provide an explanation of how the \$400 per month for amortization of painting the storage tanks was determined.
- (9) Provide a detailed analysis of the total wages and salaries paid during the test year. Also provide detail of any increase in wages during or subsequent to the test year.
- (10) Provide a copy of the water purchase contract with the City of Franklin, include any knowledge of an anticipated increase in water purchase price that the district may possess.

(11) Provide a breakdown of the actual expenses included in the following accounts during the test year.
