## ORDER

IT IS ORDERED that Country Village Sewer Company shall file an original and five copies of the following information with the Commission, with a copy to the Attorney General's Division of Consumer Intervention by October 14, 1981. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case will be dismissed.

- 1. In item 4 of your September 11, 1981, letter you stated that a breakdown of the total utility plant in service was not available. Give the reasons why this breakdown is not available. If possible assign monetary values to the items, listed below. If you are not able to do this, provide a description of your physical assets.
  - (a) Intangible plant
  - (b) Land and structures
  - (c) Collection plant
  - (d) Pumping plant
  - (e) Treatment and disposal plant
  - (f) General Plant

- 2. Is the cost of the sewer lines included in the \$36.443.42 amount?
- 3. Were bids taken from contractors to determine who would perform the lagoon cleaning? If so, provide the details of all the bids and an explanation as to why the bid that was accepted was chosen.
- 4. The letter of June 25, 1981, from the Department of Natural Resources to Mr. Bob Jones states that the lagoon cleaning should be completed by September 14, 1981. Has this project been completed? Provide copies of invoices of the actual costs of this project as soon as they are available. Please show a breakdown of labor and materials costs by the various processes involved.
- 5. When is the pump listed in Adjustment 7 of Exhibit X to be purchased? Explain the reason this new equipment is required. Provide written estimates from the company you plan to purchase the pump from. Also, indicate your proposed method of financing this capital improvement if applicable.
- 6. Provide details regarding the decision to increase the monthly sludge hauling for this plant. Include the maximum effluent allowed by the Department of Natural Resources and the effect of the additional sludge hauling on the effluent level. Also provide any written documentation from any regulatory agency requiring that the sludge hauling be increased at this time.
- 7. Provide the information required on each line under the Treatment Plant Operating Statistics Schedule shown on page 11

of the Annual Report for the past five years. This information should be supplied on the Annual Report form in order to supplement the Commission's files.

- 8. In Exhibit XXII of your September 11, 1981, response you provided copies of your monthly water and electric bills. The September, 1980, and March, 1981, water bills and the May and June, 1980, and January and February, 1981, electric bills are absent. Please provide us with a copy of these bills or an explanation for their absence. Also identify the utility plant in service or the utility business conducted at each of the two locations shown on the electric bills.
- 9. Provide an analysis of the actual expenses incurred to date with this rate case. As additional costs are incurred file these with the Commission at that time.
