AND TO EXECUTE ITS MORTGAGE NOTE FOR SAID SUMS

## ORDER

Big Sandy Rural Electric Cooperative Corporation

("Big Sandy") filed its application on September 4, 1981,

for a certificate of convenience and necessity and for

authorization to borrow the sum of \$932,000 from the United

States of America Rural Electrification Administration

("REA") and the sum of \$420,000 from the National Rural

Utilities Cooperative Finance Corporation ("CFC"), and to

execute its notes as security therefor. The funds acquired

by these borrowings are to be used to make system improve
ments and to extend service to new customers. These improve
ments and additions, which are estimated to cost \$1,331,000

are more specifically described in the application and record.

The matter was set for hearing on October 7, 1981, at 10 o'clock a.m., Eastern Daylight Time, in the offices of the Public Service Commission at Frankfort, Kentucky. The hearing was held as scheduled and all parties of interest were allowed to be heard. There were no intervenors, and no protests were entered.

The Public Service Commission, after consideration of the application and all evidence of record, and being advised, is of the opinion and finds that:

- 1. The public convenience and necessity require that such construction as is proposed in the application and record be performed, and that a certificate of convenience and necessity be granted.
- 2. The proposed borrowings are for lawful objects within the corporate purposes of the utility, are necessary and appropriate for and consistent with the proper performance by the utility of its service to the public, will not impair its ability to perform that service, and are reasonably necessary and appropriate for such purpose.

IT IS THEREFORE ORDERED that Big Sandy be and it is hereby granted a certificate of public convenience and necessity to proceed with the construction as set forth in the application and record.

IT IS FURTHER ORDERED that Big Sandy be and it is hereby authorized to borrow a sum in the principal amount

of \$932,000 from REA at the rate of 5 percent per annum over a 35-year period with payment of principal deferred for 3 years.

IT IS FURTHER ORDERED that Big Sandy be and it is hereby authorized to borrow a sum in the principal amount of \$420,000 from CFC at the initial interest rate of 14 percent per annum for a period of 7 years with the rate to be variable thereafter, over a period of 35 years.

IT IS FURTHER ORDERED that Big Sandy be and it is hereby authorized to execute its notes as security for the loans authorized herein.

IT IS FURTHER ORDERED that the proceeds from the proposed borrowings shall be used only for the lawful objects as set out in the application and record.

Nothing herein contained shall be deemed a warranty or finding of value of securities or financing authorized herein on the part of the Commonwealth of Kentucky or any agency thereof.
