PROPOSED AMENDMENT TO FEBRUARY 28, 1982 ORDER


To clarify its February 28, 1982, Order in the above-styled matter, the Commission proposes to amend the last sentence in the section identified as Phase 2(B) on page 32. The sentence as amended would state: "The Commission recommends that in the initial implementation no customer's annual bill would increase by more than ten percent over what it would have been without time-of-day rates." The Commission is of the opinion that the sentence as amended will facilitate the implementation of the time-of-day experiment.

All parties of record in this proceeding are identified in the attached service list (Attachment 1). If any of those parties believes it is adversely affected by the proposed amendment, it should notify the Commission and all others on the service list

in writing by November 15, 1982. If no such notice is received,
the amendment will be made.
