AMENDED ORDER

East Kentucky Power Cooperative, Inc., ("East Kentucky Power"), by letter filed December 21, 1981, requested that the Commission's Order in Case No. 7247, which was issued on November 17, 1978, and as amended on September 21, 1979, July 2, 1980, and January 13, 1981, be amended again so as to allow certain changes in construction plans which were authorized in said order and amendments.

The Commission, after consideration of the request, all evidence of record and being advised, is of the opinion and finds that:

1. The proposed construction changes are required due to changes in system needs since the said Orders were issued.
2. No changes will be required in the overall financing plan through the Rural Electrification Administration and the

Federal Financing Bank since the construction cost of the items proposed to be added is equal to construction cost of the items which are proposed to be deferred.

3. Public convenience and necessity require that such changes in construction as proposed in the request and record be approved and the certificate of convenience and necessity be so amended.

IT IS THEREFORE ORDERED that East Kentucky Power be and it is hereby granted an amendment to the certificate of convenience and necessity, which was granted in this case on November 17, 1978, and amended on September 21, 1979, July 2, 1980, and January 13, 1981, to incorporate the requested changes in construction as described in the letter filed by East Kentucky Power on December 21, 1981.

IT IS FURTHER ORDERED that all other provisions of the order dated November 17, 1978, and the subsequent amendments shall remain in effect.
