ORDER

IT IS ORDERED that South Central Bell Telephone Company ("South Central") shall file an original and nine copies of the following information with the Commission by January 20, 1983. Each copy of the data requested should be placed in a bound volume with each item tabbed. Where a number of sheets are required for an item, each sheet should be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. Careful attention should be given to copied material to insure that it is legible. Moreover, South Central shall furnish the name of the witness who will be responsible for responding to questions concerning each area of information outlined.

Staff Request No. 1

1. Provide the cost information listed below. Each cost study shall show the date on which it was completed. Also, each cost study shall be accompanied by a brief narrative description of each cost element, study assumptions, methods, and results, as well as supporting information necessary for analysis of each cost component.

- A. The most recent cost study used to price residence, business nonkey, key, PBX, CTX and ESSX-1 service order with premise visit charges.
- B. The cost study used to price the residence service order without premise visit charge, and the most recent cost study used to price business non-key, key, PBX, CTX and ESSX-1 service order without premise visit charges.
- C. The cost study used to price residence record type service order charge, and the most recent cost study used to price business nonkey, key, PBX, CTX and ESSX-1 record type service order charges.
- D. The cost study used to price residence, business nonkey, key, PBX, CTX and ESSX-1 central office line connection charges.
- E. The most recent cost study used to price residence and business nonkey premise wiring charges.
- F. The most recent cost study used to price residence, business nonkey, key, PBX, CTX and ESSX-1 station handling charges.
- G. The cost study used to price residence, business nonkey, key, PBX, CTX and ESSX-1 number change charges.
- H. A cost study showing rate development for separate central office line connection and access line connection charges. Access line connection shall be interpreted to include outside plant activity

associated with the installation of telephone service, installation of a protector and/or standard network interface, and allocable common costs.

- A cost study showing rate development for key,
 PBX, CTX and ESSX-1 premise wiring charges.
- J. A cost study showing rate development for residence and business nonkey station handling charges.
- 2. A statement as to why residence, business nonkey, key, PBX, CTX and ESSX-1 central office line connection and access line connection should not be separate charges.
- 3. A statement as to why key, PBX, CTX and ESSX-1 premise wiring charges should not be established.
- 4. A statement as to why residence and business nonkey station handling charges should not be established.
- 5. A statement outlining the Company's implementation of the Commission's Order in Case No. 7774, Notice of South Central Bell Telephone Company of An Adjustment in its Intrastate Rates and Charges, ordering the Company to offer the option of installment payment of service charges.
- 6. A statement as to why all service charges should not be increased.
- 7. A billing and revenue summary of all tariffed service charges.
- 8. A billing summary pertinent to service categories specified in Request Items 1-H, 1-I and 1-J.
- 9. A pro forma summary of billing units resulting from Request Items 7 and 8.

- 10. A flat rate schedule designed to generate additional revenue in the amount of \$1,589,944, based on a constant percentage increase. This request shall be interpreted to include the pricing of exchange related services. Also, the request shall be accompanied by a billing and revenue summary.
- 11. A statement as to why the flat rate schedule should not be increased on a constant percentage basis.
- 12. A long distance message telecommunications service basic rate schedule designed to generate additional revenue in the amount of \$3,462,000. This request shall be interpreted to include the pricing of related basic schedule services.

 Also, the request shall be accompanied by a billing and revenue summary. Billing units shall be specified for each matrix in the basic schedule.
