O R D E R

IT IS ORDERED that Parkway Water Association shall file an original and seven copies of the following information with the Commission by November 12, 1982. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case will be dismissed.

1. Provide a monthly breakdown of the gallons of water sold to each class of customer (i.e., residential, commercial, etc.) and the monthly losses and unaccounted for water for the 12 months ending June 30, 1982.
2. Provide an explanation of the discrepancy between the number of customers stated in the application and the average number shown in the billing analysis.
3. Provide a detailed depreciation schedule which includes the original cost, in service date, rate or service life, and accumulated depreciation for each account classification including all sub-accounts within the utility plant accounts for the 12 month period ending June 30, 1982.

4. Provide copies of the monthly water bills for the 12 months of the test year from the City Utilities Commission of Prestonsburg.

5. Provide copies of the monthly electric bills for the test year and include an explanation as to which account they are recorded and the utility facilities at each location receiving a utility bill.

6. Provide statements for property insurance and an explanation as to why this has not been an expense in the last three annual reports.

7. Provide a detailed breakdown of the costs incurred in the following accounts for the test year. At a minimum the analysis should include a brief description of each expenditure, the name of the vendor, the date and amount of purchase, and the reference or voucher number.

- A. Accounting and Collecting
- B. Outside Services Employed
- C. Maintenance of Mains

8. Provide a revised Statement of Revenue and Expenditures for the 12 months ending June 30, 1982, classified in accordance with the accounts prescribed in the Uniform Systems of Accounts.

9. Provide further details in support of the projections included in the forecasted statement of revenues and expenditures and explain the basis for the estimated increases in water revenue and various items of expense.

10. Provide a detailed analysis of the cost incurred for any legal, accounting, or other professional services acquired for the preparation of this rate application, including the payee, dollar amount, account charged, hourly rates, time charged to the utility and a brief description of the service provided,
