O R D E R

On June 3, 1983, the Public Service Commission ("Commission") entered an Order in Case No. 8612 wherein it approved the fuel adjustment charges collected by Salt River Rural Electric Cooperative Corporation ("Salt River") through the fuel adjustment clause for the period November 1, 1980, through October 31, 1982, and authorized Salt River to adjust its rates in order to transfer to its base rates fuel costs transferred by its wholesale supplier pursuant to Case No. 8588. The Commission issued an Amended Appendix A to the Order on June 27, 1983.

Salt River notified the Commission by letter dated June 29, 1983, that Amended Appendix A contains a typographical error under Rate Schedule A-5. The rate for the next 1,000 KWH block should be \$0.05623 instead of \$0.05923.


The Commission has confirmed Salt River's finding and revised the Amended Appendix A to the Order issued in this case.
