### ORDER

On June 3, 1983, the Public Service Commission ("Commission") entered on Order in Case No. 8615 wherein it approved the fuel adjustment charges collected by Taylor County Rural Electric Cooperative Corporation ("Taylor County") through the fuel adjustment clause for the period November 1, 1980, through October 31, 1982, and authorized Taylor County to adjust its rates in order to transfer to its base rates fuel costs transferred by its wholesale supplier pursuant to Case No. 8588.

The Commission has noted that Appendix A to the Order is incorrect in that Schedule GP-2 shows "greater than 25 KVA" when it should read "greater than 25 KW." Further, in Schedule SL, the energy charge adder was incorrectly rolled into the rates.

IT IS THEREFORE ORDERED that Revised Appendix A be and it hereby is approved for service rendered on and after June 1, 1983.
