ORDER ON PETITION FOR REHEARING

PROCEDURAL BACKGROUND

On April 18, 1983, the Commission issued an Order granting Continental Telephone Company of Kentucky ("Continental") \$1,519,642 in additional revenue. On May 6, 1983, Continental filed a petition requesting the Commission to rehear, reconsider and/or modify its Order. On May 26, 1983, the Commission issued an Order granting Continental reconsideration concerning alleged revenue "short-falls" and ordered Continental to file relevant information. On June 6, 1983, Continental filed the required information.

FINDINGS

The Commission, having considered the evidence of record and being advised, is of the opinion and finds that:

1. Continental's allegation of a revenue "short-fall" of approximately \$27,000 in Basic Exchange Services is correct.
2. Continental's allegation of a revenue "short-fall" of approximately \$4,000 in Miscellaneous Service Arrangements and Auxiliary Equipment is correct.

3. Continental's allegation of an error in the rate for Residence Speed Calling is correct.

4. Appendix A to the Commission's Order of April 18, 1983, should be modified consistent with findings 1 through 3.

5. A hearing on these issues is not necessary.

ORDERS


IT IS THEREFORE ORDERED that Appendix A to the Commission's Order of April 18, 1983, be and it hereby is modified as shown in the pages attached to this Order.

IT IS FURTHER ORDERED that within 30 days from the date of this Order Continental shall file revised tariff sheets with the Commission stating the rates and charges herein approved.
