O R D E R

On June 6, 1983, the Commission issued an Interim Order in Case No. 8768 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On August 8, 1983, Auxier Road Gas Company, Inc., ("Auxier") notified the Commission that its wholesale cost of gas would be increased by its supplier, Columbia Gas of Kentucky, Inc., ("Columbia") and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Auxier's notice of August 8, 1983, set out certain revisions in rates which Auxier proposed to place into effect, said rates being designed to pass on the wholesale increase in price from its supplier in the amount of \$5,222 or 7.8 cents per Mcf.

(2) Auxier's wholesale cost of gas was increased by Columbia effective July 3, 1983.

(3) Auxier's notice of August 8, 1983, requested an effective date of July 3, 1983, for its proposed rates. Auxier's notice does not provide the 20-day notice as required by statute; therefore, the proposed rates should become effective on and after August 28, 1983.


(4) Auxier's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8768 dated June 6, 1983, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after August 28, 1983.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after August 28, 1983.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Auxier shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 8768-A DATED August 15, 1983

The following rates and charges are prescribed for the customers served by Auxier Road Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

RATES: Monthly

First	1,000 cu. ft.	\$8.824 Minimum Bill
All Over	1,000 cu. ft.	8.024 per 1,000 cu. ft.

The base rate for the future application of the purchased gas adjustment clause of Auxier Road Gas Company, Inc. shall be:
