O R D E R

IT IS ORDERED that Mike Little Gas Company ("Mike Little Gas") file an original and 8 copies of the following information with the Commission by September 6, 1983. Each copy of the data requested should be placed in a volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Careful attention should be given to copied material to insure that it is legible. Where information requested herein has been provided along with the original application, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case may be dismissed.

1. Provide a listing of payroll applicable to Mike Little Gas only. This listing should follow Format 1 and provide check date, check number, payee, hours worked and amount. This listing should exclude payroll for Elzie Neeley Inc., and salaried officers. Provide copies of the checks listed.

2. Provide a reconciliation between total annual payroll in 1 above and the payroll summary sheets provided in response to the Commission's Order dated, May 19, 1983, Item No. 1 for Mike Little Gas only.

3. Provide a reconciliation between the annual payroll shown above and that shown in the 1982 Annual Report on file with this Commission.

4. Provide a reconciliation between payroll amount shown in the original application and in Item 1 above.

5. Provide a breakdown of radio equipment investment allocated by company and include depreciation expense by company for same as shown in Format II.

6. Provide an aging of gas payables to Kentucky West Virginia Gas Company and include a brief statement explaining any delinquencies.

7. Provide a statement as to the Company's justification for using the 5 year estimated life of the system map.
