O R D E R

On May 4, 1983, Berea College Electric Utility Department ("Berea Electric"), by counsel, filed its Motion to Amend Orders in the above case and in Case No. 8805. Among other things, the Motion states that Berea Electric and Blue Grass Rural Electric Cooperative Corporation ("Blue Grass Electric") are the sole suppliers of electric service within the corporate limits of Berea, Kentucky. The Motion further states that Blue Grass Electric has within its service area a portion of the City of Berea which contains approximately 150 customers, that the balance of the City of Berea lies within the service area of

Berea Electric, and that the Commission's Orders entered April 12, 1983, (Berea Electric) and April 14, 1983, (Blue Grass Electric) conflict with KRS 278.017 and KRS 278.018 by allowing each utility to bid upon a franchise in the service area of the other. (The service area of each utility is established pursuant to KRS 278.017 and KRS 278.018.)

In its Application in Case No. 8805, Blue Grass Electric requested a certificate of convenience and necessity to bid on a franchise for the territory it now serves in the City of Berea.

Berea Electric moves the Commission for an amendment of the above Orders to reflect that each is authorized to bid upon a franchise for that portion of its certified service area that is within the municipal boundaries of the City of Berea.

The Commission, having considered the Motion and being advised, HEREBY ORDERS that the Motion be and it hereby is sustained to the extent that the first paragraph on the last page of the Commission's Order entered April 12, 1983, in Case No. 8791 be and it hereby is amended as follows:

IT IS THEREFORE ORDERED That Berea Electric be and it hereby is granted a certificate of convenience and necessity which authorizes it to bid on an electric franchise for that portion of its certified service area that is within the municipal boundaries of the City of Berea.


The Commission, on its own motion, HEREBY ORDERS that the first ordering paragraph on the last page of the Commission's Order entered April 14, 1983, in Case No. 8805 be and it hereby is amended as follows:

IT IS THEREFORE ORDERED That Blue Grass Electric be and it hereby is granted a certificate of convenience and necessity to bid on an electric franchise for that portion of its certified service area that is within the municipal boundaries of the City of Berea.

IT IS FURTHER ORDERED That all other provisions of the Commission's Orders entered April 12, 1983, in Case No. 8791, and April 14, 1983, in Case No. 8805, not amended herein, shall remain in full force and effect.
