AMENDED ORDER OF PROCEDURE

The Commission, having considered its hearing schedule during the months of October and November, 1983, including the number of major hearings to be held during that period, on its own motion, HEREBY ORDERS that commencing with the second literary paragraph on Page 3 of the Commission's Order of Procedure entered July 7, 1983, said Order be and it hereby is amended as follows:

IT IS FURTHER ORDERED That on or before August 12, 1983, Kentucky-American shall mail or deliver Responses to the original Requests for Information with copies to parties of record and 12 copies to be submitted to the Commission, and all Responses shall identify the witness or witnesses who will be responsible for responding to questions relating to each request for information.

IT IS FURTHER ORDERED That on or before August 22, 1983, all Supplemental Requests for Information (to include only those matters within the scope of the initial request) to Kentucky-American shall be due, with copies to parties of record and 12 copies to be submitted to the Commission.

IT IS FURTHER ORDERED That on or before August 31, 1983, Kentucky-American shall mail or deliver Responses to Supplemental Requests for Information, with copies to parties of record and 12 copies to be submitted to the Commission, and all Supplemental Responses shall identify the witness or witnesses who will be responsible for responding to questions relating to each request for information.

IT IS FURTHER ORDERED That on or before September 7, 1983, Intervenors shall file their testimony in verified prepared form, with copies to parties of record and 12 copies to be submitted to the Commission.

IT IS FURTHER ORDERED That on or before September 19, 1983, all Requests for Information to Intervenors shall be due with copies to parties of record and 12 copies to be submitted to the Commission.

IT IS FURTHER ORDERED That Intervenors shall mail or deliver on or before September 28, 1983, Responses to Requests for Information, with copies to parties of record and 12 copies to be submitted to the Commission, and the Responses shall identify the witness or witnesses who will be responsible for responding to questions relating to each request for information.

IT IS FURTHER ORDERED That a hearing be and it hereby is scheduled to commence on October 6, 1983, at 9:00 a.m., Eastern Daylight Time, in the Commission's offices at Frankfort, Kentucky, for the purpose of cross-examination of witnesses of Kentucky-American, cross-examination of witnesses of Intervenors, and the presentation of rebuttal testimony, if any, by Kentucky-American.

IT IS FURTHER ORDERED That Kentucky-American and Inter-
venors shall file briefs, indexed by subject matter, simultaneously
by the close of business November 7, 1983.

IT IS FURTHER ORDERED That all other provisions of the
Commission's Order of Procedure entered July 7, 1983, not amended
herein, shall remain in full force and effect.
