IT IS ORDERED that South Central Bell Telephone Company ("SCB") shall file an original and 15 copies of the following information with the Commission on or before November 23, 1983. Each copy of the data requested should be placed in a bound volume with each Item tabbed. When a number of sheets is required for an Item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of Include with each response the name of the witness who 6. will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to insure that it is legible. Where information requested herein has been provided along with the original application, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. When applicable, the information requested herein should be provided for total company operations and Kentucky jurisdictional operations, separately. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case may be dismissed.

The Commission is requesting this information in order to clarify previous responses and exhibits which are insufficient in scope and/or detail to allow adequate preparation for the hearing.

With reference to Column G of Ballard's Exhibit
Part 2, provide a detailed explanation of each entry made,
i.e., revenue, license contract, etc.

2. When were these reimbursements made to South Central Bell of Kentucky?

3. What were the amounts of these reimbursements to South Central Bell of Kentucky? to intrastate operations?

4. Identify the accounting treatment given to these reimbursements. Was this the accounting treatment recommended by the FCC in its November 4th, 1982, Memorandum Opinion and Order in Docket 82-4967

5. Please explain the relationship between column G and the response to Item 6 of Staff Request No. 2 in which you show the CI-II reimbursement to South Central Bell of Kentucky to be \$2,678,724.

6. Provide all journal entries and the date of entry related to this reimbursement for CI-II expenses from the time of first recognition to the present date.

7. Provide a complete explanation of the treatment of CI-II expenses and subsequent reimbursement in the settlements of toll revenues with other Kentucky telephone companies.

8. Provide the propsectus for BellSouth filed with the SEC when it becomes available.

9. On November 16, 1983, AT&T filed financial data with the SEC prior to the start of trading in the stocks of the seven Bell regional companies. Included in the material is a 267 page "core document." Please provide the Commission with copies of this document. Additionally, provide any other data filed with the SEC specific to BellSouth.
