ORDER OF PROCEDURE

IT IS FURTHER ORDERED That where notice of the hearing pursuant to KRS 424.300 is published by Union Light, Heat and Power Company ("ULH&P") in a newspaper, it shall be published in a newspaper of general circulation in the areas that will be affected one time not less than seven nor more than twenty-one days prior to the hearing giving the purpose, time, place and date of hearing.

IT IS FURTHER ORDERED That on or before August 8, 1983, ULH&P shall file its testimony in verified prepared form.

IT IS FURTHER ORDERED That on or before August 15, 1983, all Requests for Information to ULH&P shall be due, with copies to parties of record and 12 copies to be submitted to the Commission.

IT IS FURTHER ORDERED That on or before August 22, 1983, ULH&P shall mail or deliver Responses to the original Requests for Information, with copies to parties of record and 12 copies to be submitted to the Commission, and all Responses shall identify the witness or witnesses who will be responsible for responding to questions relating to each request for information.

IT IS FURTHER ORDERED That on or before August 31, 1983, Intervenors shall file their testimony in verified prepared form, with copies to parties of record and 12 copies to be submitted to the Commission.

IT IS FURTHER ORDERED That on or before September 6, 1983, all Requests for Information to Intervenors shall be due, with copies to parties of record and 12 copies to be submitted to the Commission.

IT IS FURTHER ORDERED That Intervenors shall mail or deliver Responses to Requests for Information on or before September 13, 1983, with copies to parties of record and 12 copies to be submitted to the Commission, and the Responses shall identify the witness or witnesses who will be responsible for responding to questions relating to each request for information.

IT IS FURTHER ORDERED That all requests for information and responses thereto shall be appropriately indexed.

IT IS FURTHER ORDERED That ULH&P and Intervenors shall file briefs, indexed by subject matter, simultaneously by the close of business October 20, 1983.

IT IS FURTHER ORDERED That Motions for extensions of time with respect to the schedule herein will be granted only upon a showing of compelling reasons.

IT IS FURTHER ORDERED That nothing contained herein shall prevent the Commission from entering further Orders in this matter.
