### INTERIM ORDER

On August 10, 1981, the Commission issued its Order in Case No. 8114 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On October 23, 1984, East Kentucky Utilities, Inc., ("East Kentucky") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Kentucky West Virginia Gas Company ("Kentucky West"), effective November 1, 1984, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) East Kentucky's notice of October 23, 1984, set out certain revisions in rates which East Kentucky proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$19,184 or 10.98 cents per Dth. (2) Kentucky West filed an application for decreased rates to become effective November 1, 1984, with the Federal Energy Regulatory Commission.

(3) East Kentucky's proposed rates included gas purchases from Southeastern Gas Company ("Southeastern") at a rate of \$3.50 per Mcf. This rate is under investigation by the Commission in Case No. 8114-J, and should not be allowed in the calculation of East Kentucky's revised rates. The rates in the Appendix to this Order should be placed in effect on an interim basis pending a final Order in Case No. 8114-J.

(4) East Kentucky's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8114 dated August 10, 1981, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after November 1, 1984.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after November 1, 1984.

IT IS FURTHER ORDERED that within 30 days of the date of this Order East Kentucky shall file with this Commission its revised tariffs setting out the rates authorized herein.

The following rates and charges are prescribed for the customers served by East Rentucky Utilities, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Minimum Bill: \$5.40 for less than 1 Mcf.
