ORDER

On July 6, 1982, the Commission issued its Order in Case No. 8425 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On April 19, 1984, Mountain Utilities, Inc., ("Mountain") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Kentucky West Virginia Gas Company ("Kentucky West"), effective May 1, 1984, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record filed in this case and being advised, the Commission is of the opinion and finds that:

(1) Mountain's notice of April 19, 1984, set out certain revisions in rates which Mountain proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$93,118.

- (2) Kentucky West filed an application for decreased rates to become effective May 1, 1984, with the Federal Energy Regulatory Commission.
- (3) Mountain's notice of April 19, 1984, contained an error in the calculation of the decrease in rates. The reduction should be \$1.0945 per Mcf rather than \$1.1112 as proposed.
- (4) Mountain's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8425 dated July 6, 1982, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after May 1, 1984.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after May 1, 1984.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Mountain shall file with this Commission its revised tariffs setting out the rates authorized herein.
