ORDER

On November 30, 1982, the Commission issued its Order in Case No. 8562 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On October 1, 1984, Phelps Gas Company, Inc., ("Phelps") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas of Kentucky, Inc., ("Columbia") effective September 1, 1984, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Phelps' notice of October 1, 1984, set out certain revisions in rates which Phelps proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$320 or 1.3 cents per Mcf.

- (2) Phelps' wholesale cost of gas was decreased by Columbia effective September 1, 1984.
- (3) Phelps' notice of October 1, 1984, requested an effective date of October 1, 1984, for its proposed rates. The proposed rates should be effective on and after September 4, 1984, to coincide with the effective date of the rate revision in Case No. 8562-0.
- (4) Phelps should report to the Commission any excess revenues collected during the period from September 4, 1984, to the date the proposed rates are implemented, along with a plan to refund any excess collections to its customers.
- (5) Phelps' proposed adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8562 dated November 30, 1982, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after September 4, 1984.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after September 4, 1984.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Phelps shall report to the Commission any excess revenues collected during the period from September 4, 1984, to the date the proposed rates are implemented, along with a plan to refund any excess collections.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Phelps shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 8562-P DATED OCTOBER 12, 1984

The following rates and charges are prescribed for the customers served by Phelps Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

RATES: Monthly

First 1 Mcf Over 1 Mcf \$9.10 Minimum Bill

6.80 Per Mcf

The base rate for the future application of the purchased gas adjustment clause of Phelps Gas Company, Inc., shall be:
