O R D E R

On May 16, 1984, East Clark County Water District ("East Clark") filed its application with the Public Service Commission ("Commission") seeking approval of a purchased water adjustment clause and authority to adjust its rates in accordance with that clause.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) The purchased water adjustment clause sought by East Clark is in compliance with 807 KAR 5:067, Purchased Water Adjustment Clause, and is in the best interest of East Clark and the public and should be approved.

(2) East Clark's supplier, Winchester Municipal Utilities, increased the wholesale cost of water from \$.87 to \$1.12 per 1,000 gallons, effective with the bill rendered in July 1984.

(3) The statements of water purchased and sold filed by East Clark for the 12-month period ending April 30, 1984,

show that its water loss is approximately 6.9 percent which is less than the maximum 15 percent allowed by the Commission.

(4) The total allowable increase in purchased water costs is \$11,569 resulting in a purchased water adjustment of \$.27 per 1,000 gallons.

(5) The financial information filed by East Clark indicates that it cannot absorb an increase of this magnitude.

(6) The purchased water adjustment in the amount of \$.27 per 1,000 gallons and the rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment clause filed by East Clark be and it hereby is approved effective on and after the date of this Order.

IT IS FURTHER ORDERED that the purchased water adjustment in the amount of \$.27 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for services rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of East Clark, the base rate for purchased water shall be:

Winchester Municipal Utilities	\$1.12 per 1,000 gallons

IT IS FURTHER ORDERED that within 30 days of the date of this Order, East Clark shall file its revised tariff sheets setting out the purchased water adjustment clause and the rates approved herein.

APPENDIX A

APPENDIX TO AN ORDER OF THE PUBLIC SERVICE
COMMISSION IN CASE NO. 8644-1 DATED
AUGUST 7, 1984

The following rates are prescribed for customers served by East Clark County Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

<u>GALLONAGE BLOCKS</u>	<u>RATES</u>
First 2,000 gallons	\$9.14 Minimum Bill
Next 2,000 gallons	3.92 per 1,000 gallons
Next 3,000 gallons	3.42 per 1,000 gallons
Next 3,000 gallons	2.82 per 1,000 gallons
Over 10,000 gallons	2.17 per 1,000 gallons

Meter Rates to Multi-Unit Premises

Water bills to all multi-unit premises, including duplexes, apartment buildings, trailer parks, mobile home parks, and premises containing both a permanent dwelling and a mobile home or trailer, having a single master meter, shall be computed by dividing the number of gallons of water registered by such master meter in each month by the number of units on such premises, and the bill for each unit shall be computed from the rate schedule. The amount of the unit bill so computed shall then be multiplied by the number of units on the premises on the day the meter is read, to establish the monthly bill for such premises. The minimum monthly bill to each multi-unit premises shall be \$9.41 multiplied by the number of units on the premises on the date the meter is read.

Bulk Water Sales	3.75 per 1,000 gallons
