ORDER

On March 1, 1983, the Commission issued its Order in Case No. 8678 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On August 8, 1984, Western Lewis-Rectorville Water and Gas District ("Western Lewis") notified the Commission that its wholesale cost of gas would be increased by its supplier, Columbia Gas Transmission Corporation ("Transmission"), effective September 1, 1984, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Western Lewis' notice of August 8, 1984, set out certain revisions in rates which Western Lewis proposed to place into effect, said rates being designed to pass on the wholesale increase in gas cost in the amount of \$10,976 or 18.56 cents per Dth.

(2) Transmission has filed an application for revised rates to become effective September 1, 1984, with the Federal Energy Regulatory Commission.

(3) Western Lewis' adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8678 dated March 1, 1983, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after September 1, 1984, subject to refund. This adjustment is subject to refund because Transmission's increase is subject to refund.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after September 1, 1984, subject to refund.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Western Lewis shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE PUBLIC SERVICE  
COMMISSION IN CASE NO. 8678-M DATED 8/27/84

The following rates are prescribed for the customers served by Western Lewis-Rectorville Water and Gas District (Gas Division). All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the date of this Order.

Rates:        Monthly

First	1,000 cu. ft. or less	\$7.68 (Minimum Bill)
Next	4,000 cu. ft. per 1,000 cu. ft.	5.5605
Next	5,000 cu. ft. per 1,000 cu. ft.	5.5105
Over	10,000 cu. ft. per 1,000 cu. ft.	5.4105

The base rate for the future application of the purchased gas adjustment clause of Western Lewis-Rectorville Water and Gas District (Gas Division) shall be:
