AMENDED ORDER

On February 7, 1983, Duo County Telephone Cooperative Corporation, Inc., ("Duo County") filed with the Commission its application for authorization to borrow \$3,785,450 for the purpose of providing service to projected new subscribers and complete Duo County's service upgrade program.

On May 4, 1984, the Commission issued an Order granting Duo County a certificate of public convenience and necessity to proceed with the proposed construction as set forth in the application and record.

The Commission, after further review and consideration of the application and all evidence of record and being advised, is of the opinion and finds that: 1. Duo County should be allowed to charge the individual line rate authorized in Case No. 8153, Application of Duo County Telephone Cooperative Corporation, Inc., Jamestown, Kentucky 42629 for Authority to Implement an Adjustment in its Uniform Subscriber Rates, and subsequent cases for like upgraded service.

2. Duo County should notify the Commission when the proposed construction in the Burkesville and Fairplay exchanges is completed and upgraded.

3. Duo County should file with the Commission the appropriate tariffs that relate to any rate change as the result of any upgrading in service.

IT IS THEREFORE ORDERED that Duo County shall be allowed to adjust the rates for service in the Burkesville and Fairplay exchanges to the individual line rate for upgraded service allowed in Case No. 8153 and subsequent cases, when the proposed upgrading of the individual exchanges is completed.

IT IS FURTHER ORDERED that Duo County shall notify the Commission when the proposed upgrading of the Burkesville or the Fairplay exchange is completed and they shall file with the Commission appropriate tariffs that relate to any such change.

IT IS FURTHER ORDERED that, except for the above changes, the Commission's Order of May 4, 1984, remains in full force and effect.
