Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to insure that it is legible. Where information requested herein has been provided along with the original application, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. When applicable, the information requested herein should be provided for total company operations and jurisdictional operations, separately. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case may be dismissed.

 Regarding Exhibit 8 ("Represcription of Depreciation Rates") filed in response to the Commission's Order of June 20, 1984, provide <u>for each month</u> of the 12 month period ending May 31, 1984:

a. Intrastate Depreciation Ratio (line 2).

b. Intrastate ITC Amortization Ratio (line 6).

c. Intrastate Ratio - Effect on Average Net Investment
 (line 10).

d. Intrastate Ratio - Effect on Average Deferred Taxes
(line 13).

2. Regarding Exhibit 7, item 2 (Management Salary Plan Change Effective April 1, 1984), provide justification for including this adjustment in this case, as the Commission disallowed this adjustment in Case No. 8847 (page 27 of the Order of January 18, 1984).

Regarding regulatory adjustments presented on Exhibit
 provide workpapers, calculations and/or explanations to support
 the amount of each adjustment.

4. Please provide a collated set of tariff pages filed to implement Appendices A to the Commission's Orders of January 18, 1984, and June 29, 1984.

5. Please provide a collated set of tariff pages which state multi-element service charges and outside base rate area charges.
