ORDER

On July 2, 1984, the City of Oak Grove, Christian County, Kentucky, ("City") and Oak Grove Utility Company, Inc., ("Oak Grove") filed a joint application requesting Commission approval of the sale and transfer of the Oak Grove water treatment and distribution system to the City.

Based on the evidence of record and being advised, the Commission is of the opinion and hereby finds that:

1. Oak Grove desires to sell its water treatment and distribution system and the City desires to acquire and operate said system.

2. Oak Grove and the City entered into a sales agreement dated June 28, 1984, setting forth the rights and obligations of each party with respect to the sale and transfer of the Oak Grove water treatment and distribution system.

3. The City will continue to employ persons experienced in the operation of the waterworks system, including the present manager of Oak Grove, and the city will provide adequate, efficient and reasonable water service to its customers.

4. Within 5 days of the date of sale and transfer, Oak Grove and the City should file with the Commission a joint notice setting forth the date of sale and transfer.

5. Within 90 days subsequent to the date of sale and transfer, Oak Grove should file with the Commission its 1984 Annual Report covering the period January 1, 1984, through the date of sale.

IT IS THEREFORE ORDERED that the sale and transfer of the water treatment and distribution system of Oak Grove to the City be and it hereby is approved.

IT IS FURTHER ORDERED that within 5 days of the date of the sale and transfer Oak Grove and the city shall file with the Commission a joint notice setting forth the date of sale and transfer.

IT IS FURTHER ORDERED that within 90 days of the date of sale and transfer Oak Grove shall file with the Commission its 1984 Annual Report.
