O R D E R

On September 11, 1984, Delong Electronics ("Delong") filed its application for a certificate of public convenience and necessity to operate as a radiotelephone utility providing mobile telephone service in the Johnson County area in Kentucky.

Delong is a Kentucky proprietorship owned and operated by Paul R. Delong, P. O. Box 1253, Paintsville, Kentucky 41240. The system is automatic and does not use operators, and will remain in operation 24 hours a day. The system will be maintained by Paul R. Delong, Radio Telephone License No. PG - 19-4340.

The system will operate on a frequency of 152.12 Mhz with an effective radiated power of 44.7 WATS. The antenna will be located at Boons Camp, Kentucky, at 37° 50' 45" N. latitude, 82° 40' 55" W. longitude.

The Commission, having considered the evidence of record and being advised, is of the opinion and finds that:

(1) Delong has applied for a Federal Communications Commission ("FCC") license for this operation.

(2) Delong should supply a copy of the FCC license to the Commission before it becomes operational.

(3) Having an FCC radio telephone license, Paul Delong is capable of maintaining the system.

(4) Delong should be granted a certificate of public convenience and necessity to provide mobile telephone service in the Johnson County area in Kentucky.

(5) The rates as filed should be approved.

(6) Customer deposits should be placed in escrow.

IT IS THEREFORE ORDERED that Delong Electronics be and it hereby is granted a certificate of public convenience and necessity.


IT IS FURTHER ORDERED that Delong shall file with the Commission a copy of its FCC license before the system goes into operation.


IT IS FURTHER ORDERED that all of DeLong's customer deposits shall be placed in escrow and its tariffs shall state this.

IT IS FURTHER ORDERED that the proposed rates are approved and that Delong shall file its tariffs containing its rates, rules and regulations in the manner prescribed by the Commission within 30 days prior to the institution of service.
