O R D E R

The Commission issued an Order in this case on November 15, 1985, wherein it granted Delta Natural Gas Company, Inc., ("Delta") an additional \$451,946 in annual revenues. Upon a review of its working papers, the Commission has found that two errors were made which resulted in a deficiency in the revenue requirement found reasonable.

First, in an error of omission, the Commission failed to include the annual amortization expense associated with the amortization of the acquisition costs of Peoples Gas Company of \$21,859, and also failed to include amortization expense of \$15,194 annually for the amortization of an organizational and compensation study. Amortization of both of these expenses was included for rate-making purposes in Case No. 9059, An Adjustment Of Rates Of Delta Natural Gas Company, Inc.

The second issue in which the Commission erred was in the calculation of normalized income tax expense. The Commission erroneously excluded \$20,250 in income tax expense associated with the Federal surtax exemption on the first \$100,000 of corporate taxable income. The Federal surtax exemption of \$20,250 has been

eliminated by an additional tax of 5 percent on annual income between \$1,000,000 and \$1,405,000 for large corporations.

Based on the previous discussion, the Commission has determined that additional revenues of \$77,484 above those granted in its Order dated November 15, 1985, should be allowed. The additional revenues are determined as follows:

IT IS THEREFORE ORDERED that:


1. The allowed revenues be increased by \$77,484 annually, based upon the findings herein.


2. The rates and charges in Appendix A shall, to the extent of their differences, supersede the rates authorized in the Commission's Order of November 15, 1985, and are hereby approved for service rendered by Delta on and after the date of this Order.

3. All other aspects not specifically mentioned herein of the Commission's Order of November 15, 1985, are hereby affirmed.
