O R D E R

IT IS HEREBY ORDERED that Multi-Page, Incorporated, ("Multi-Page") shall file the original and 10 copies of the following information within 3 weeks of the date of this Order. If the requested information or a motion for extension of time is not filed by the stated date, the case may be dismissed without prejudice.

1. In Case No. 9242, the Joint Application of Multi-Page, Inc., and Commonwealth Telecommunications, Inc., dated February 12, 1985, a portion of Multi-Page's assets and service area was transferred to Commonwealth Telecommunications, Inc.

(a) Provide a map showing all areas currently served by Multi-Page and the area proposed to be served.

2. Will customers in the currently certificated area and in the proposed area be served under the same tariff? If not, explain why.

3. Provide a schedule for current and proposed rates in comparative form. Where differences occur in services and/or rates, provide explanation as follows:

(a) If all customers are to be served under the same tariff, designate the correct rate proposed to be charged and explain the reason for any change from the current tariff.

(b) If customers in the proposed area are to be served under a different tariff, explain why the rates and/or service should be different.

(c) Provide detailed cost justification for connection charges and any other non-recurring charges of this nature not contained in the current tariff.


4. Provide a billing analysis for a 1-month period, based on customers being served at the time of filing, showing the number of customer's billings applicable to each rate element and the revenues which would be generated from both current and proposed rates.

5. Provide a similar billing analysis for new customers anticipated to be served within 1 year after initiation of service in the area proposed to be certificated.

6. Please present an income statement for Multi-Page to coincide with the period for the balance sheet which was presented (period ending August 31, 1985). Section 6 of 807 KAR 5:001 requires the presentation of an income statement.
