On September 30, 1985, Treyton Oak Towers filed its informal complaint against South Central Bell Telephone Company ("South Central Bell") with the Public Service Commission ("Commission"), a copy of which is attached. Treyton Oak Towers selected an informal complaint rather than a formal complaint because it hoped that the matter could be resolved in an efficient and expeditious manner. Treyton Oak Towers asked the Commission to schedule an informal conference between it, South Central Bell and the Commission staff at the Commission's earliest convenience.

On November 11, 1985, Treyton Oak Towers secured a copy of South Central Bell's November 1, 1985, response to its informal complaint. In its response, South Central Bell asked the Commission to inform Treyton Oak Towers that South Central Bell acted correctly. South Central Bell offered no accommodation to Treyton Oak Towers regarding any of the concerns expressed in the informal complaint. Treyton Oak Towers is not satisfied with South Central Bell's response.

Treyton Oak Towers respectfully requests that the Commission treat its informal complaint as a formal complaint pursuant to Section 12 of 807 KAR 5:001, as the informal complaint
