O R D E R

On October 20, 1986, East Clark County Water District ("East Clark") filed an application for rehearing seeking reconsideration of several expense adjustments it had proposed, but which were not included in the determination of revenue requirements. Being advised, the Commission will grant reconsideration of the maintenance of mains expense. After due consideration of the evidence, the Commission will deny rehearing as to all other issues.

In the Order of September 30, 1986, the Commission excluded an adjustment of \$6,050 in proposed additional maintenance of mains expense associated with the approved expansion of East Clark's system. East Clark contends that the Commission, while recognizing that additional maintenance costs would be incurred, had failed to allow for these additional expenses. Upon reconsideration, the Commission believes \$6,050 in projected maintenance expense is not unreasonable and has, therefore, included this for rate-making purposes.

IT IS THEREFORE ORDERED that:


1. Except as to the maintenance of mains expense and the rates affected thereby, the Commission's Order dated October 20, 1986, be and it hereby is affirmed.

2. The rates in Appendix A be and they hereby are approved for service rendered by East Clark on and after the date of this Order.

3. Within 30 days from the date of this Order East Clark shall file with this Commission its revised tariff sheets setting out the rates approved herein.

All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Next 2,000 Gallons	4.75 Per 1,000 Gallons
Next 3,000 Gallons	4.10 Per 1,000 Gallons
Next 3,000 Gallons	3.35 Per 1,000 Gallons
Over 10,000 Gallons	2.50 Per 1,000 Gallons
