IT IS ORDERED that Mike Little Gas Company, Inc., ("MLG") shall file an original and eight copies of the following information with this Commission, with a copy to all parties of record. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to insure that it is legible. The information requested herein is due no later than December 30, 1986. If the information cannot be provided by this date, you should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it will be furnished. Such motion will be considered by the Commission.

1. With reference to the Appraisal Report, page 2, it is reflected therein that 1,500 square feet is leased for storage space while page 7 states that \$60,000 to \$100,000 of inventory is presently stored therein. Provide a current breakdown of inventory currently held in this storage space.

2. With reference to page 2 of the submission of information upon rehearing, provide the following information, a. Explain why the location of a tenant's customer base is a legitimate factor for setting its rental charge.

3. With reference to the submission of information, Item No. 5, provide <u>detailed</u> descriptions of how the square footage is used as was originally requested.

4. With reference to the submission of information, ItemNo. 6, provide the following information:

a. Clarify the rent charged to each of the cable companies (\$200 each or \$200 combined)?

b. Explain how the rental charge was determined for the cable companies.

c. State the number of customers each cable company has.

d. Identify the service area for each of the cable companies.

5. Following is a comprehensive list of small gas utilities located in the Eastern Kentucky area for which rent expense information is available:

d. How frequently does MLG make deposits?

e. How many days had it been prior to the theft that MLG made a deposit?

f. What steps were taken to recover the stolen money?
