O R D E R

On July 16, 1986, Salt Lick Water Association, Inc., ("Salt Lick") filed with the Public Service Commission ("Commission") its revised tariff sheet setting forth its rate as adjusted pursuant to KRS 278.012, 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, is of the opinion and finds that:

1. Salt Lick's supplier, City of Vanceburg, increased its wholesale rate for purchased water from \$.78 to \$1.61 per 1,000 gallons by contract modification dated June 10, 1986.

2. Salt Lick purchased 12,295,200 gallons of water during the 12-month period ending April 30, 1986, and sold 9,701,100 gallons.

3. Salt Lick's calculations are correct and show an increase in purchased water costs of \$10,205, resulting in a purchased water adjustment of \$1.06 per 1,000 gallons.

4. Salt Lick adjusted the rates to its customers by \$1.06 per 1,000 gallons, effective July 15, 1986.

5. The tariff sheet filed by Salt Lick is correct with the exception that it was not signed by the officer authorized to issue the tariff as required by 807 KAR 5:011, Section 4(4)(a). The tariff sheet should be returned for signature and refiling with the Commission.


IT IS THEREFORE ORDERED that:

1. The rates as adjusted by Salt Lick and shown in Appendix A be and they hereby are approved effective for services rendered on and after July 15, 1986.


2. The tariff sheet shall be returned to Salt Lick for signature and refiling with the Commission. The signed tariff sheet shall be refiled within 30 days of the date of this Order.
