O R D E R

On August 13, 1986, Northern Rockcastle County Water District ("Northern Rockcastle") filed its revised tariff sheet with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068. Subsequently, on September 2, 1986, in response to the Commission's request, Northern Rockcastle filed additional information for the purpose of determining the correctness of its calculations and rates.

The Commission having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. Northern Rockcastle's supplier, City of Mt. Vernon, increased its rate for purchased water from \$.42 to \$.84 per 1,000 gallons, effective April 30, 1986.

2. During the 12-month period ending May 31, 1986, Northern Rockcastle purchased 35,918,800 gallons of water and sold 29,353,660 gallons.

3. The calculations made by Northern Rockcastle are incorrect in that the purchased water adjustment was based on the exact difference between the base rate and the changed rate of the

supplier (\$.84 - \$.42 = \$.42) rather than the difference in the actual cost of water purchased under the base rate and changed rate.

4. The actual increase in purchased water costs is \$15,112 resulting in a purchased water adjustment of \$.51 per 1,000 gallons, as shown by the calculations in Appendix B to this Order.

5. The rates proposed by Northern Rockcastle are incorrect and should be denied.

6. The purchased water adjustment in the amount of \$.51 per 1,000 gallons and the rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Northern Rockcastle be and they hereby are denied.

2. The purchased water adjustment in the amount of \$.51 per 1,000 gallons and the rates in Appendix A be and they hereby are approved.

3. Within 30 days of the date of this Order, Northern Rockcastle shall file its revised tariff sheet with the Commission setting out the rates approved herein.

The following rates and charges are prescribed for customers receiving water service from Northern Rockcastle County Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Next 50,000 Gallons	1.51 Per 1,000 Gallons
Over 100,000 Gallons	1.31 Per 1,000 Gallons

Minimum Bills

All usage in excess of the minimum shall be billed in accordance with the rate schedule.
