O R D E R

On August 27, 1986, Garrard County Water Association ("Garrard") filed its revised tariff sheets with the Public Service Commission ("Commission") setting forth its rates as adjusted pursuant to KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. Garrard's supplier, City of Lancaster, increased its wholesale rate for purchased water from \$1.05 to \$1.20 per 1,000 gallons, effective August 15, 1986.
2. Garrard purchased 146,653,610 gallons of water and sold 112,519,078 gallons during the 12-month period ending June 30, 1986.
3. Garrard's calculations are correct and show an increase in purchased water costs of \$21,998, resulting in a purchased water adjustment of \$.20 per 1,000 gallons.
4. Garrard adjusted the rates to its customers by \$.20 per 1,000 gallons effective September 1, 1986.
5. The rates and the revised tariff sheet filed by Garrard are correct and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates as adjusted by Garrard and shown in Appendix A be and they hereby are approved.

2. The revised tariff sheet filed by Garrard be and it hereby is approved as filed.

The following rates and charges are prescribed for the customers in the area served by Garrard County Water Association. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Next	1,000 Gallons	3.95 per 1,000 Gallons
Next	1,000 Gallons	2.95 per 1,000 Gallons
Next	2,000 Gallons	2.45 per 1,000 Gallons
All Over	5,000 Gallons	1.95 per 1,000 Gallons

LARGE COMMERCIAL, DAIRY FARM, AND SCHOOL CONNECTIONS

1" Meter Schedule

First	5,000 Gallons	\$19.75 (Minimum Bill)
All Over	5,000 Gallons	1.95 per 1,000 Gallons

1 1/2" Meter Schedule

First	10,000 Gallons	\$29.50 (Minimum Bill)
All Over	10,000 Gallons	1.95 per 1,000 Gallons

2" Meter Schedule

First	25,000 Gallons	\$58.75 (Minimum Bill)
All Over	25,000 Gallons	1.95 per 1,000 Gallons

BULK SALES

\$3.20 per 1,000 Gallons
