O R D E R

On August 29, 1986, Kentucky CGSA, Inc. ("Kentucky CGSA"), on behalf of Lexington MSA Limited Partnership ("Lexington MSA"), filed its application for a certificate of public convenience and necessity to provide cellular radio telecommunications service in the Lexington metropolitan statistical area, as described in its application, and to construct the necessary facilities to provide such service. Lexington MSA is a limited partnership between GTE Mobilnet, Inc., and Kentucky CGSA. The latter is a subsidiary of Bell South Mobility, Inc., and is the operating partner in the partnership.

On September 11, 1986, Lexington MSA was notified that its application was deficient in certain filing requirements. Information filed on September 26, 1986, corrected these deficiencies.

On October 13, 1986, the Commission ordered that additional information be filed. This was filed on October 31, 1986, completing the record in this case.

The Commission, having considered the application and evidence of record, and being advised, is of the opinion and finds that:

(1) Lexington MSA's general partner, Kentucky CGSA, is technically capable of providing cellular telephone service;

(2) Lexington MSA is financially capable and ready to begin construction of the necessary facilities required to provide cellular telephone service; and

(3) The proposed rates, rules, and regulations filed with the application are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


(1) Lexington MSA be granted a certificate of public convenience and necessity to provide cellular telecommunications service in the Lexington metropolitan statistical area as described in its application;


(2) The proposed rates, rules, and regulations filed with the application are fair, just and reasonable and are approved; and

(3) Lexington MSA shall file tariffs reflecting the rates, rules, and regulations approved herein within 30 days from the date of this Order.
