O R D E R

On October 9, 1986, Lone Oak Water District ("Lone Oak") filed revised tariff sheets with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. Lone Oak's supplier, Paducah Water Works, increased its rates for wholesale water by approximately \$.26 per 1,000 gallons of water, effective April 23, 1982.
2. Lone Oak purchased 186,725,000 gallons of water and sold 173,007,600 gallons during the 12-month period ending August 31, 1986.
3. Lone Oak's calculations are correct and show an increase in purchased water costs of \$48,443, resulting in a purchased water adjustment of \$.28 per 1,000 gallons.
4. Lone Oak proposes to adjust the rates to its customers effective November 1, 1986.
5. The tariff sheet filed by Lone Oak is correct and should be approved as filed.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Lone Oak and shown in Appendix A be and they hereby are approved effective for services rendered on and after November 1, 1986.

2. The tariff sheet filed by Lone Oak is approved as filed.

3. Within 30 days of the date of this Order, Lone Oak shall file proof of publication of its notice to customers.
