ORDER

On February 26, 1987, Sanitation District No. 1 of Montgomery County ("Montgomery") filed its application seeking to increase its rates pursuant to the Alternative Rate Filing Procedure for Small Utilities.

Neither Montgomery nor the Commission sought a hearing in this matter. There were no intervenors and all requested information has been filed.

On April 7, 1987, the Commission staff conducted a field review of Montgomery's test period financial records and issued its report on July 15, 1987, containing the staff's recommendations. After careful review and investigation of the staff's recommendations the Commission is of the opinion that Montgomery will have adequate cash flow to meet its obligations and provide for future equity growth. Therefore, the Commission affirms the staff's recommended increase of \$3,472 and emphasizes the staff's advice regarding Montgomery's monitoring of its future operations in order to determine Montgomery's future financial needs.

FINDINGS AND ORDERS

- 1. The rates and charges in Appendix A are the fair, just, and reasonable rates and charges to be charged by Montgomery in that they should produce annual revenues of \$35,174.
- 2. Within 30 days of the date of this Order, Montgomery should file with this Commission its revised tariff sheets setting out the rates approved herein.

IT IS THEREFORE ORDERED that:

- 1. The rates and charges in Appendix A are the fair, just, and reasonable rates and charges to be charged by Montgomery for service rendered on and after the date of this Order.
- 2. Within 30 days of the date of this Order, Montgomery shall file with this Commission its revised tariff sheets setting out the rates approved herein.
