ORDER

IT IS ORDERED that Southeast Daviess County Water District ("Southeast Daviess") shall file an original and seven copies of the following information with the Commission with a copy to all parties of record no later than June 1, 1987. If the information cannot be provided by this date, Southeast Daviess should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it will be furnished. Such motion will be considered by the Commission. Southeast Daviess shall furnish with each response the name of the witness who will be available at the public hearing for responding to questions concerning each item of information requested.

1. Provide a summary of any operational deficiencies of the existing water system that have been indicated by hydraulic analyses or that are known from experience.

2. Provide detailed information on Southeast Daviess' source of supply. Identify fully, connection points, location of treatment facilities, pumping facilities, and other appurtenances required to furnish water to the District.

3. Provide a map of suitable scale that clearly shows the layout of the Southeast Daviess' existing water mains with pipe sizes clearly shown. The map shall show the locations of connections with sources of supply and identify connection points of Southeast Daviess' resale customers.

4. Southeast Daviess shall furnish complete information on its water storage facilities. This information shall include the type, capacity, and location of each storage facility.

5. Provide the total water consumption for Southeast Daviess for the year 1986. Provide the average daily water consumption and the largest one-day consumption for the same period.

6. Provide the total amount of water sold to each of Southeast Daviess' resale customers during 1986. Identify the largest one-day amount sold to each of these resale customers in 1986.

7. State whether Southeast Daviess has any financial obligation to the Farmers Home Administration. If so, provide a copy of correspondence from FmHA containing its comments on Southeast Daviess' storage situation.

8. During the history of Southeast Daviess' operation has the source of water supply ever been out of service? If so, what was the longest period of interruption?

9. In the event of an interruption in the source of water supply how will water be provided for such places as schools, hospitals, and other critical facilities?

10. Provide copies of the curtailment procedures of Southeast Daviess' source of water supply and Southeast Daviess' procedures for its resale customers. Provide copies of Southeast Daviess' water purchase agreements and its water sales agreements.
