AMENDED ORDER

On October 1, 1987, the Commission issued an Order granting Mike Little Gas Company, Inc., ("Mike Little Gas") a surcharge to pay off a loan from the First Commonwealth Bank of Prestonsburg, Kentucky, the proceeds of the loan to be paid to Kentucky-West Virginia Gas Company for past due gas bills. The surcharge, pending notice to customers, is to be effective October 21, 1987.

In addition to the requirements set forth in the Order of October 1, 1987, the Commission finds that Mike Little Gas should file additional information prior to the implementation of the surcharge on October 21, 1987.

IT IS THEREFORE ORDERED that:

1. Mike Little Gas shall file a copy of the signed and dated loan agreement between Mike Little Gas and the First Commonwealth Bank of Prestonsburg, Kentucky, on or before October 21, 1987.

2. Mike Little Gas shall file a signed letter and any other supporting documentation from Kentucky-West Virginia Gas Company, stating that it is in receipt of the \$100,000 payment and that said payment met the terms of the negotiated settlement. This information is to be filed on or before October 21, 1987.

3. The Order of October 1, 1987, with the exception of the amendments herein shall remain in full force and effect.

APPENDIX TO AN ORDER OF THE PUBLIC SERVICE
COMMISSION IN CASE NO. 8924-P DATED 10/9/87

The following rates and charges are prescribed for the customers served by Louisville Gas and Electric Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.

Gas Supply Cost Adjustment:

The monthly amount computed at the charge specified in each of the rate schedules to which this Gas Supply Cost Adjustment is applicable shall be increased (or decreased) by the following charge:

(9.003¢) per 100 cubic feet of gas used during the period covered by the bill

The base rates for the future application of the gas supply cost adjustment clause of Louisville Gas and Electric Company shall be:
