O R D E R

On May 1, 1987, MCI Telecommunications Corporation ("MCI") filed a tariff that introduced Prism Plus service. On May 13, 1987, the tariff was suspended for further investigation.

On June 30, 1987, the Commission granted interim approval of the Prism Plus tariff pending the further investigation and made the tariff subject to certain stipulations that were described in the Interim Order.

On July 23, 1987, MCI filed another tariff with the Commission wherein it proposed to introduce two additional services, Prism I and Prism II. These are one-way multi-point services in which the customer originates calls via dedicated facilities between the customer's premises and MCI's terminal locations.

The Commission is of the opinion that further investigation and possible hearing will be necessary to determine the reasonableness of the proposed tariffs.

The Commission is also of the opinion that because of the similarity of the filing made on July 23, 1987, to the previous filing made May 1, 1987, they should be consolidated into this instant case. The style of this instant case should be altered to read as follows:

IT IS THEREFORE ORDERED that:

1. The tariff filing for Prism I and Prism II services be and hereby are consolidated into this instant case.


2. The style of this instant case shall be altered to read as previously mentioned in this Order.


