## ORDER

IT IS ORDERED that Kentucky CGSA, Inc., ("Kentucky CGSA"), shall file an original and ten copies of the following information with the Commission, with a copy to all parties of record. The information requested herein is due no later than November 20, 1987. If the information cannot be provided by this date, Kentucky CGSA should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it will be furnished. Such motion will be considered by the Commission.

1. In Case No. 9679, "The Application of Lexington MSA Limited Partnership for the Issuance of a Certificate of Public Convenience and Necessity to Provide a New Domestic Public Cellular Radio Telecommunications Service to the Public in the Greater Lexington Metropolitan Area Including All, or Parts of, Bourbon, Clark, Fayette, Jessamine, Scott and Woodford Counties in Kentucky and Tariff Approval," the response filed on October 31, 1986, to the Commission's Order dated October 13, 1986, Item 2, states, in part, "Sites C and D are sites for future growth and enhanced coverage and are filed for informational purposes only." Is Site D referenced above the same as the Site D referenced in your October 2, 1987, letter? If so, affirm that all information filed in Case No. 9679 pertaining to Site D is still applicable, or provide appropriate corrections.

2. If the response to Item 1 above is in the negative, provide a full description of the proposed new construction including a description of the manner in which it will be constructed. As a minimum, this should include:

a. A legible 3º dBu contour map.

b. A verticle profile sketch.

c. A description of the tower.

3. Provide a copy of the Federal Aviation Administration's approval, or a copy of the application if not yet approved.

4. Provide a copy of the leasing agreement or deed.

5. Provide assurance in the form of a statement or zoning certificate which acknowledges that the proposed tower is in compliance with all local zoning ordinances. If this is not possible, provide an explanation. Additionally, provide the address and point-of-contact of the relevant zoning commission.

6. Provide a listing and description of all estimated construction costs.

7. Provide a listing and description of all annual operating expenses.
