### ORDER

On August 10, 1987, the Commission issued its Order in Case No. 9918 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On October 24, 1988, Mt. Olivet Natural Gas Company, Inc., ("Mt. Olivet") notified the Commission that it received an increase in rates from its supplier, Columbia Gas Transmission Corporation ("Transmission"), effective October 18, 1988, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Mt. Olivet's notice of October 24, 1988 set out certain revisions in rates which Mt. Olivet proposed to place into effect, said rates being designed to pass on the wholesale increase in gas cost from its supplier in the amount of \$1,644 or 4.18 cents per Mcf. (2) Transmission filed revised rates with the FERC to be effective October 18, 1988. These rates are subject to refund.

KRS 278.180 requires 30-days' notice of a change in (3) rates with the Commission having the discretion to shorten the required period from 30 days to not less than 20 days upon showing Reduction in rates will, as always, be made of good cause. effective with the date of the supplier decrease. Increases in rates will be effective with 20-days' notice provided the company has included in its filing a specific request that a tariff sheet or some other notification from the supplier be considered a showing of good cause. In no case, however, shall the effective date be made prior to the actual effective date of the supplier. Mt. Olivet included a request for a showing of good cause for 20-days' notice. The effective date will, therefore, be 20 days after Mt. Olivet's notice, or November 13, 1988.

(4) Mt. Olivet's adjustments in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 9918 dated August 10, 1987 are fair, just, and reasonable and in the public interest and should be effective with gas supplied on and after November 13, 1988.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after November 13, 1988.

(2) Within 30 days of the date of this Order Mt. Olivet shall file with this Commission its revised tariffs setting out the rates authorized herein.
