AMENDED ORDER

On June 29, 1988, the Commission issued an Order in Case No. 10139 granting Harold Telephone Company ("Harold") the authority to charge for custom calling features and denying the establishment of a late payment charge. On July 7, 1988, the Commission issued an additional Order amending Appendix A in the June 29, 1988 Order.

On July 18, 1988, Harold filed a request to amend the June 29, 1988 Order to include a monthly recurring charge for toll denial. Provided in the request was information showing that the expenses and revenue requirement for the toll denial feature was included in the original application. Harold also showed that inclusion of the toll denial feature would increase total operating income by \$141; however, the effect on the absorption test computed as of December 31, 1987 would be nominal. Finally, Harold indicated that toll denial has for sometime been a part of its total custom calling package, but by inadvertence was omitted from the original application.

Based on the information filed, the Commission is of the opinion that Harold's request to amend the June 29, 1988 Order should be granted.

IT IS THEREFORE ORDERED that:

1. Harold's request to amend the June 29, 1988 Order to include the charge for toll denial shall be granted.

2. The rates and charges in Appendix A to this Order be and they hereby are approved for services rendered effective on and after June 29, 1988.

Within 30 days from the date of this Order, Harold shall file its tariff sheets setting out the rates and charges approved herein.
