### ORDER

On January 21, 1988, Overland Development, Inc. ("Overland"), filed its application seeking to increase its rates by \$2,564, a 12 percent increase over reported test period revenues of \$21,368 pursuant to the Alternative Rate Filing Procedure for Small Utilities.

on February 25, 1988, the Commission Staff ("Staff") conducted a field review of Overland's test period financial records. On April 14, 1988, Staff issued its report containing its recommendation for a \$7,906 increase over normalized revenues of \$16,152. On April 21, 1988, Overland filed a letter in which it stated its acceptance of Staff's findings and recommendations.

Neither Overland nor the Commission sought a hearing in this matter. There were no intervenors and all requested information has been filed.

After careful review and investigation of Staff's recommendations, the Commission is of the opinion that after Staff's proposals are implemented Overland will have adequate cash

flow to meet its obligations and provide for future equity growth. Therefore, the Commission affirms Staff's recommended increase of \$7,906.

## FINDINGS AND ORDERS

- 1. Overland should be granted rates which would produce additional annual revenues of \$7,906.
- 2. The rates and charges in Appendix A are the fair, just, and reasonable rates and charges to be charged by Overland in that they should produce annual revenues of \$24,058.
- 3. Within 30 days of the date of this Order, Overland should file with this Commission its revised tariff sheets setting out the rates approved herein.

IT IS THEREFORE ORDERED that:

- 1. Overland be and hereby is granted rates to produce additional annual revenues of \$7,906.
- 2. The rates and charges in Appendix A are the fair, just, and reasonable rates and charges to be charged by Overland for service rendered on and after the date of this Order.
- 3. Within 30 days of the date of this Order Overland shall file with this Commission its revised tariff setting out the rates approved herein.
