ORDER OF PROCEDURE

On March 30, 1988, Hardin County Water District No. 1 ("Hardin County") filed an application with the Commission wherein it proposed to adjust its wholesale and retail rates for water service.

The Commission is of the opinion and finds that, pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed rates.

IT IS THEREFORE ORDERED that:

1. The procedural schedule listed in Appendix A shall be followed.

2. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of

the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 12 copies to the Commission.

3. The report filed by the Commission Staff on August 15, 1988, shall be considered as the prepared testimony of the Commission Staff.


4. Hardin County shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
