O R D E R

In the Order of November 30, 1988, the Commission advised Columbia Gas of Kentucky, Inc. ("Columbia"), of its option to request an immediate increase in rates for the purpose of generating additional annual revenues of \$80,225. This amount, resulting from a transposition error in the rate base allowed Columbia in the Commission's rate Order of October 21, 1988 represents additional revenue above the increase of \$2,280,396 previously granted.

On December 12, 1988, Columbia exercised its option and requested an adjustment of rates in order to generate additional annual revenues of \$80,225. The Commission is of the opinion and finds that Columbia's request should be granted and that the rates in Appendix A will produce the additional \$80,225 in revenue.

IT IS THEREFORE ORDERED that:

1. The rates in Appendix A be and they hereby are approved for service rendered by Columbia on and after the date of this Order.
2. Within 30 days from the date of this Order Columbia shall file with the Commission its revised tariff sheets setting out the rates approved herein.
