ORDER

On June 3, 1988, East Pendleton Water District ("East Pendleton") filed an application to increase its service connection fee for a 5/8 x 3/4 inch meter and to establish special service charges for service reconnection, meter reading recheck, meter test, and returned checks. On June 16, 1988, the Commission issued a letter to East Pendleton requesting additional information requiring certain filing deficiencies to be filed by July 1, 1988. Because it received no response to this letter, the Commission issued another letter on July 27, 1988 requesting the deficient information be filed within 10 days. On July 28, 1988, East Pendleton filed the additional information requested with the exception of proof of publication of the proposed charges. August 2, 1988, the Commission issued a letter requesting an affidavit of publication be filed no later than August 9, 1988. On August 5, 1988, East Pendleton filed the necessary document.

East Pendleton has filed schedules with the Commission which itemize the expenses involved in providing a metered service connection, a service reconnection, a meter reading recheck, a meter test, and a return check charge. A review of these

schedules shows that the proposed charges are equal to the expense of each charge and that the individual expenses are reasonable.

The Commission having considered the evidence and being advised, is of the opinion and finds that:

- 1. East Pendleton should be granted an increase in its service connection fee for a $5/8 \times 3/4$ inch meter as set out in Appendix A.
- 2. East Pendleton should be permitted to establish a service reconnection charge, a meter reading recheck charge, a meter test charge, and a returned check charge, as set out in Appendix A.
- 3. East Pendleton should file within 30 days from the date of this Order its revised tariff sheets setting out the charges approved herein.

SO BE IT ORDERED.
