ORDER

IT IS ORDERED that the parties shall file the original and 12 copies of the following information with the Commission, with a copy to all parties of record. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible.

The information requested is due no later than May 15, 1989. If the information cannot be provided by this date, a motion for an extension of time must be submitted stating the reason for the delay and the date by which the information can be furnished. Such motion will be considered by the Commission.

InterLATA¹ Carriers

1. (a) Identify all WATS² resellers to which the company sells telecommunications network access or transmission capacity in Kentucky. List each reseller separately according to the name under which it conducts business.

(b) For each reseller identified above, indicate whether MTS³ or MTS-like services or facilities are sold for resale to end users.

(c) For each reseller identified above, indicate whether WATS or WATS-like services or facilities are sold for resale to end users.

(d) For each reseller identified above, indicate whether private line or private line-like services or facilities, including foreign exchange service, are sold for resale to end users.
