O R D E R

IT IS ORDERED that A & B Sanitation Company ("A & B Sanitation") shall file the original and 12 copies of the following information with the Commission with a copy to all parties of record no later than 14 days from the date of this Order. Careful attention should be given to copied material to ensure that it is legible. If the information cannot be provided by this date, A & B Sanitation should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it will be furnished. Such motion will be considered by the Commission.

- 1. Where are the offices of A & B Sanitation now located?
- 2. If A & B Sanitation has acquired rental office space since August 7, 1989, provide a copy of the rental agreement for this office space. State the date when the rental agreement was executed, the monthly rent for this office space, and the size of the office space.
- 3. If A & B Sanitation has not yet acquired rental office space, explain why it has not done so. Describe A & B

Sanitation's efforts since August 7, 1989 to acquire office space. List the names and addresses of the realtors whom A & B Sanitation has consulted in its search for rental office space.

- 4. If A & B Sanitation has not yet acquired rental office space, when does it expect to do so?
- 5. List the names of all persons currently having an ownership interest in A & B Sanitation.
- 6. List the names of all persons who have had an ownership interest in A & B Sanitation since March 1, 1988.
- 7. Explain any changes in the ownership of A & B Sanitation which have occurred since March 1, 1988.
- 8. Does Darrell Angle currently have an ownership interest in A & B Sanitation?
- 9. Has Darrell Angle had any ownership interest in A & B Sanitation since March 1988? If yes, describe his interest.
- 10. On August 18, 1989, A & B Sanitation filed with the Commission what it purported to be a copy of its 1988 federal and state income tax returns. Do those filed documents accurately reflect the documents which A & B Sanitation submitted to the Internal Revenue Service and the Kentucky Revenue Cabinet? If no, provide a true copy of A & B's 1988 federal and state income tax returns and explain why an inaccurate copy of A & B's income tax returns was filed with the Commission.
- 11. In his testimony before the Commission on February 19, 1989, Mr. Bil Darby testified that he was the sole stockholder of A & B Sanitation. The copy of A & B Sanitation's 1988 federal and state income tax returns lists Mr. Darrell Angle as currently

owning 49.3 percent of the stock of A & B Sanitation. Explain this discrepancy and indicate whether the testimony or the tax returns are correct.
