ORDER

On March 21, 1989, the Commission issued its Order in Case No. 10398 approving certain adjustments and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On May 23, 1989, Mountain Utilities, Inc. ("Mountain") notified the Commission that its wholesale cost of gas had been decreased by its supplier, Kentucky West Virginia Gas Company ("Kentucky West"), effective May 1, 1989, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Mountain's notice of May 23, 1989 set out certain revisions in rates which Mountain proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$28,600 or 49.53 cents per Mcf.

- (2) Kentucky West filed an application for decreased rates to be effective May 1, 1989 with the Federal Energy Regulatory Commission.
- (3) Mountain should file with this Commission the amount of overcollections received between May 1, 1989 and the date the reduced rates are implemented, along with a refund plan.
- (4) Mountain's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 10398 dated March 21, 1989 is fair, just, and reasonable and in the public interest and should be effective with gas supplied on and after May 1, 1989.

IT IS HEREBY ORDERED that:

- (1) The rates in the Appendix, attached and incorporated hereto, are fair, just, and reasonable and are approved effective with gas supplied on and after May 1, 1989.
- (2) Within 30 days of the date of this Order, Mountain shall file with this Commission its revised tariffs setting out the rates authorized herein.
- (3) Within 20 days of the date of this Order, Mountain shall file the amount of any overcollections related to this rate reduction, along with a refund plan.

The following rates and charges are prescribed for the customers served by Mountain Utilities, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

RATES: Monthly

First 1 Mcf \$8.0595 Per Mcf Over 1 Mcf \$7.2995 Per Mcf

Minimum Bill: \$8.06 for less than 1 Mcf.
